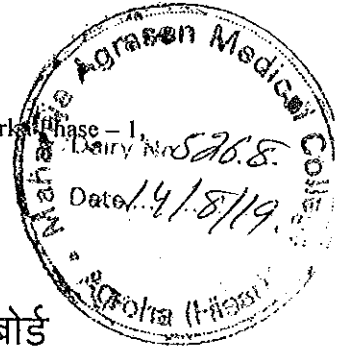

B.D. Sharma University of Health Sciences, Rohtak and decided as under: -

"The Board of Governors considered the Council Assessor's Report (04.06.2019) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that MD(Anaesthesiology) qualification for 02 seats granted by Pt. B.D. Sharma University of Health Sciences, Rohtak in respect of students being trained at Maharaja Agrasen Medical College, Agroha be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

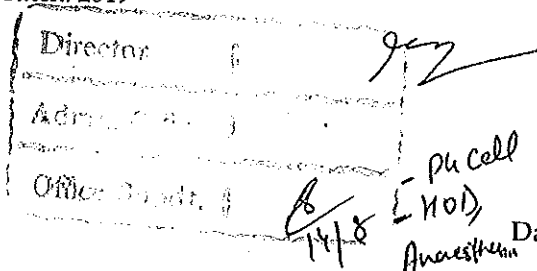
