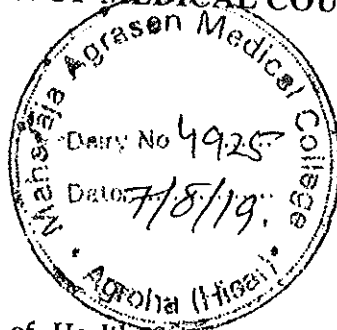

Sir/Madam,

I am directed to state that the Board of Governors considered the Assessment Report (27.05.2019) on the standard of examination and other teaching facilities available at Maharaja Agrasen Medical College, Agroha for purpose of Recognition of MD(Pathology) qualification for 02 seats granted by Pt. B.D. Sharma University of Health Sciences, Rohtak and decided as under: -

"The Board of Governors considered the Council Assessor's Report (27.05.2019) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that MD(Pathology) qualification for 02 seats granted by Pt. B.D. Sharma University of Health Sciences, Rohtak in respect of students being trained at Maharaja Agrasen Medical College, Agroha be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
