## GUIDELINES FOR ELECTIONS OF 200 ELECTORAL COLLEGES TO ELECT THE MEMBERS OF COLLEGIUM OF THE SOCIETY AND OTHER RELEVANT DESCRIPTIONS & INFORMATION

#### 1. <u>General</u>

The next elections of the collegium have been notified on 14.12.2023 and the list of members of the society and list of members of 200 Electoral Colleges have been published on the same day. One member each from 200 Electoral Colleges is to be elected as per Election Schedule, displayed on the Website and Notice Board of the society. Notice of the election schedule has also been sent to all the members of the society by speed post. Guidelines of the Elections and other relevant descriptions and information, in view of the provisions of the Haryana Registration & Regulation of Societies Act and rules-2012 and bye-laws of the society, are given hereunder in further paras.

# 2. <u>Eligibility conditions for a candidate for election of member of Collegium (one</u> <u>member each from 200 Electoral Colleges), documents to be submitted alongwith</u> <u>nomination paper & other terms & conditions of elections are as under:-</u>

- A Candidate must be a member of the society and his name should exist in the list of the Electoral College from which Electoral College he wants to seek election.
- ii. A Candidate should have not been convicted of an offence involving moral turpitude punishable with imprisonment of one year or more.
- iii. If a member of the society, although his name exists in the list of members of society and also in the list of Electoral Colleges, but he is an employee of the society or its any institution, he is not eligible to seek election.
- iv. A Candidate shall have to submit the nomination paper, in prescribed form, in PERSON himself / herself before the Returning Officer.

- v. A Member of the society can seek election from the Electoral College in which his name exists as member.
- vi. A Candidate, on demand by the Returning Officer shall have to present his identity proof, in original, at the time of nomination, out of Identity card issued by the society, if any, Elector Photo Identity Card, Passport, Driving License, PAN Card, Aadhar Card, Senior Citizen Card or any other ID Card issued by any Govt. Office, acceptable to the Returning Officer and a photocopy of ID Proof will be attached with the nomination form by the candidate, duly self attested.
- vii. A contesting candidate can appoint his election agent and polling agent from the members of the Society only, to attend the polling and counting on behalf of the candidate and no person other than the member of the society can be appointed as agent.

## 3. <u>Model Code of Conduct</u>

Model code of conduct for a candidate shall remain in force from the date of nomination by him / her till the completion of election process. Election propaganda, if any, shall be closed at <u>3:00 P.M. on 14.01.2024</u>.

### 4. Eligibility of voter & his Identification

- A member of the society whose name exists in the list of 200 different Electoral Colleges shall be eligible to vote in the same Electoral College in which his / her name exists.
- ii) A voter should have not been convicted of an offence involving moral turpitude punishable with imprisonment of one year or more.
- iii) A member of the society, who is an employee of the society or its any institution even if his / her name exists in the list of members will not be eligible to vote.
- iii) A voter, on demand by the Returning Officer or the Presiding Officer shall have to present his identity proof, in original, at the time of polling of votes. The acceptable proofs of identity are Identity card issued by the society, if any, Elector Photo Identity Card, Passport, Driving License, PAN Card, Aadhar Card, Senior Citizen Card or any other ID Card issued by any Govt. Office. However, the Returning Officer or Presiding Officer shall have the discretion to accept or reject the identity proof due to valid reasons.

### 5. Polling and Counting of Votes & Declaration of Results

The voters shall be allowed to cast their votes, in person. Voting shall be by secret ballot paper. The counting of the votes will be conducted in the presence of the candidates or their agents by and under the control of Returning Officer / Presiding Officer. After counting of votes the results will be declared by the Returning Officer and the same shall also be displayed on the notice board and website of the society. The polling & counting of votes will be under the supervision and observation of the Observer / representative of the District Registrar of Societies, Hisar, if appointed by him.

**Note: -** All the members of the society are informed that after the elections of the Members of Collegium, the office bearers and executive members of the Governing Body will be elected by the members of the Collegium including Founder Members of the Society for which notice of elections of the Governing Body, along with schedule of election, will be issued later on to the members of the Collegium.
