- 1. Students should be available in their respective rooms as attendance will be taken in your respective blocks everyday between 9:00pm 10:15pm in the biometric machines without fail.
- 2. Students should stay <u>only in the room allotted to them</u>. Staying in other student's room is not permissible.
- 3. Any physical/mental harassment towards fellow students including ragging, quarrelling, using abusive language and **violent behavior** is strictly prohibited. I would not participate in any strike or illegal activity.
- 4. **Smoking** is strictly prohibited inside the Hostel premises and within the campus of the institute.
- 5. Hostel is meant for facilitating studies. Therefore, **silence** should be maintained between 9.00pmto6.00am.Students should not disturb other students by conducting parties, playing music, talking loudly over mobile phones, etc.,
- 6. Multi-Level Marketing (MLM) and **gambling** in any form including playing cards in the hostel is prohibited.
- 7. Students found entering the Institution/Hostel premises under the influence of alcohol or inducing others to consume alcohol, will be suspended for one semester and fine of Rs. 25000/- will be imposed. If a student is found consuming/possessing (even empty bottles) liquor inside the campus/hostel premises he will be suspended for one year.
- 8. If **narcotics** or related substances are found in any room, all the students staying in the room will be **expelled** from the institution. Students who consume/trade/possess narcotics inside / outside the hostel will be expelled from College. Abuse of any chemicals is prohibited.
- 9. Any one causing **damage** to the hostel **property** will be **penalized** suitably.
- 10. Hostel students should **not bring any day-scholar** or **ex-MAMC Students** or **non-MAMC Students** inside the hostel premises.

- 11. If a student is going out for an overnight stay, he should **obtain prior permission (Concerned Warden)** before leaving the hostel as per procedure.
- 12. Hostellers are not allowed to keep any kind of motor vehicles. However, bicycles can be used.
- 13. Students in the hostel are not allowed to keep musical instruments, speakers, kettle, induction stove, electric iron box or any other electrical equipment/gadgets. Unauthorized possession will lead to confiscation of the goods. Cooking in the rooms is strictly not permitted because of fire safety reasons.
- 14. Students are **personally responsible to safeguard their belongings**. Students are advised not to keep large amounts of cash or valuables like gold, costly wrist watch/laptops/cell phone, expensive jewellery etc., in their rooms.

Students will be permitted to go on leave to Hometown/Local guardian's place after parent's approval with concerned warden permission.

- 15. Students will not be permitted to stay in the hostel during **vacation**, unless they have academic assignments.
- 16. Those who stay in Hostel have to pay the mess bill in advance quarterly.
- 17. Hostel charges will depend on A.C. / Cooler / Regular Room.
