

JOINTAFFIDAVITBY PARENT/GUARDIANANDSTUDENT

Agrasen Medical College, Agroha (Hisar) do hereby undertake.

1. That after joining the course I will abide by the rules regulations of College and Hostel.
2. That I will abide by the rules/law/instructions issued from time to time.
3. I am aware that violation of rules/law/instructions regarding ragging would attract Penal/disciplinary action against me.
4. That I will abide by the dress/uniform code.
5. That I have read the relevant instructions/regulations against ragging, as well as punishment. I will comply the instructions/ regulations and in case I found guilty at any stage, disciplinary action as per above guidelines may be taken against me.
6. I hereby declare that I hold myself responsible for the timely payment of all the dues i.e. tuition fee, fines, canteen, mess and other charges etc. payable to Medical College and during the period of his/her studies in medical college & Hospital.
7. I declare that he/she has never been disqualified by any University/Board.
8. Students should be available in their respective hostel by 9:00 PM.
9. Students should stay **only in the room allotted to them**. Staying in other student's room is not permissible.
10. Any physical/mental harassment towards fellow students including ragging, quarrelling, using abusive language and **violent behavior** is strictly prohibited. I would not participate in any strike or illegal activity.
11. **Smoking and consumption of Alcohol** is strictly prohibited inside the Hostel premises and within the campus of the institute.
12. Hostel is meant for facilitating studies. Therefore, **silence** should be maintained between 9.00 pm to 6.00 am. Students should not disturb other students by conducting parties, playing music, talking loudly over mobile phones, etc.

13. Multi-Level Marketing (MLM) and **gambling** in any form including playing cards in the hostel is prohibited.
14. Students found entering the Institution/Hostel premises under the influence of alcohol or inducing others to consume alcohol, will be **suspended for one semester and fine of Rs. 25000/-** will be imposed. If a student is found **consuming/possessing (even empty bottles)** liquor inside the campus/hostel premises he will be **suspended for one year**.
15. If **narcotics** or related substances are found in any room, all the students staying in the room will be **expelled** from the institution. Students who consume/trade/possess narcotics inside / outside the hostel will be expelled from College. Abuse of any chemicals is prohibited.
16. Any one causing **damage** to the hostel **property** will be **penalized** suitably as decided by college authorities.
17. Hostel students should **not bring any day-scholar or ex-MAMC Students or non-MAMC Students** inside the hostel premises.
18. If a student is going out for an overnight stay, he should **obtain prior permission (Concerned Warden)** before leaving the hostel as per procedure.
19. Hostellers are not allowed to keep any kind of motor vehicles. However, bicycles can be used.
20. Students in the hostel are not allowed to keep **musical instruments, speakers, kettle, induction stove, electric iron box or any other electrical equipment/gadgets**. Unauthorized possession will lead to confiscation of the goods. Cooking in the rooms is strictly not permitted because of fire safety reasons.
21. Students are **personally responsible to safeguard their belongings**. Students are advised not to keep large amounts of cash or valuables like gold, costly wrist watch/laptops/cell phone, expensive jewellery etc., in their rooms.

Students will be permitted to go on leave to Hometown/Local guardian's place after parent's approval with concerned warden permission.
22. Students will not be permitted to stay in the hostel during **vacation**, unless they have academic assignments.
23. Those who stay in Hostel have to pay the full mess bill in advance.
24. Hostel charges will depend on A.C. / Cooler / Regular Room.
